SECTION SIX – 2020 MEMBERSHIP DECLARATION FORM

The Main Competitors/Co-Drivers agree to perform and abide by the following terms and conditions:

Entry Cancellation: To receive a full refund of an entry fee, notice must be made in writing to the Masters Historic Racing Office at least 14 calendar days prior to the start of the event to which the entry fee applies.

Terms for Participation:

- i. In consideration of **Masters Historic Racing Ltd** (“Masters”) acceptance for participation in Masters Events this year, the undersigned owner, competitor, driver and/or co-driver of race car(s) accepted for such Event(s) (“Participants”), on behalf of himself/herself and his/her respective next of kin, personal representatives, successors and assigns, hereby:
- ii. RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, Participants, racing associations, sanctioning organizations, **Masters Historic Racing Ltd** (“Masters”) track operators, track owners, track officials, track employees, car owners, drivers, mechanics, pit crews, corner workers, stewards, race officials, and any persons in any RESTRICTED AREA during the Events, rescue personnel, advertisers, sponsors, owners and lessees of the Event venue, and Event inspectors, scrutineers, surveyors, underwriters, consultants and others who offer recommendations, directions and instructions or engage in risk evaluation or loss control activities regarding the premises, race cars, Participants or otherwise relating to the Event, and each of them, and each of their respective officers, directors, agents, legal representatives, employees, contractors, members, consultants, affiliates, successors and assigns (collectively referenced herein as “Releasees”) FROM ALL LIABILITY TO THE UNDERSIGNED, and his/her personal representatives, successors, assigns, heirs and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIMS OR DEMANDS THEREFOR, ON ACCOUNT OF INJURY TO PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED, ARISING FROM OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
- iii. ACKNOWLEDGES THAT MOTOR RACING AND OTHER COMPETITION EVENTS ARE DANGEROUS for Participants, as well as spectators, mechanics, safety workers, and others within the Event venue, and involves the risk of serious bodily injury, death and/or property damage, and further acknowledges that injuries may be compounded or increased by negligent rescue operations or procedures of the Releasees.
- iv. AGREES TO DEFEND, INDEMNIFY AND HOLD HARMLESS the Releasees, and each of them, FROM ANY LOSS, LIABILITY, DAMAGE OR COST they may incur arising out of or related to INJURY OR DEATH OF THE UNDERSIGNED, OR DAMAGE TO PROPERTY OF THE UNDERSIGNED, or otherwise arising from or related to the UNDERSIGNED’S PARTICIPATION IN THE EVENT(S).
- v. ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising from or related to the Event(s), WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.
- vi. AGREES that this Release, and Waiver of Liability, Assumption of Risk, Covenant not to Sue and Indemnity Agreement extends to all act of negligence by Releasees INCLUDING, WITHOUT LIMITATION, NEGLIGENT RESCUE OPERATIONS, and is intended to be as broad and inclusive as is permitted under applicable law; and that if any portion thereof is held invalid, the balance, notwithstanding, shall remain in full force and effect.
- vii. REPRESENTS, WARRANTS AND CONFIRMS that the race car entered and described in this application meets both the letter and spirit of the **FIA and/or** Masters Technical and Sporting Regulations (which the undersigned acknowledges having read and understood) currently in force for the Class in which such car is entered and, having consulted with the race car preparer, that such race car meets applicable safety requirements and is otherwise fit for competition.
- viii. REPRESENTS, WARRANTS AND CONFIRMS that he/she has read and understand the relevant Masters, FIA, Motorsports UK and all other applicable rules and regulations.
- ix. REPRESENTS, WARRANTS AND CONFIRMS that he/she has read, understands and agrees to abide by the Master Racing Club Rules and Masters Racing Club Code of Conduct (available on www.mastershistoricracing.com)
- x. REPRESENTS, WARRANTS AND CONFIRMS that he/she no known health issues or problems that may affect participation in the race series and will notify Masters and/or refrain from participation in the race series if there are any changes of such circumstance during the season.
- xi. Save to the extent that FIA has jurisdiction, any dispute arising out of or in connection with this agreement shall be subject to the jurisdiction of the Laws of England and Wales. In the event of litigation, the prevailing party shall be entitled to reasonable attorneys’ fees and costs.
- xii. AGREES AND ACCEPTS THAT the undersigned’s name, and his or her race car details, may be shared with both Event and race organizers for the management of the race Event(s), and may be used publicly through Event entry lists, Event publicity and marketing, and reports on Event results.
- xiii. GRANTS PERMISSION AND CONSENT to Masters and other Event organizers or promoters for Participants, including the undersigned and his/her race car(s), to be filmed, digitally recorded, live streams or photographed in connection with the Event, and for such film, digital recording, live streaming or photographs to be used in electronic, print and social media, including for commercial promotion, marketing and sales.
